A New Year in Our Neighborhood

The Arlington Forest Citizens Association enters 2012 ready to continue its mission of advancing the interests of our neighborhood. Issues which AFCA will address in the coming months include: traffic and pedestrian safety issues along our streets, planning for the second-annual neighborhood-wide cleanup to be held in April on Earth Day weekend, and plans for summer 2012 performances at the newly-renovated Lubber Run Amphitheater.

The coming months will also feature the AFCA-sponsored annual community yard sale and AFCA's annual picnic and election. As new issues arise, AFCA will address them as well to give voice to our community in discussions with local officials.

The first AFCA meeting of the year is Jan 18 at 7 PM in the

Barrett School library. The agenda includes a review of ongoing issues as well as planning for upcoming AFCA activities. If you have an issue to raise or if you just want to see your association in action, please attend. Meetings rarely exceed one hour.

Finally, if you have not yet sent in your \$10 AFCA dues for the September 2011 to August 2012 fiscal year, please do so today and send it to your association's Vice President using the form on page 9. Your dues support AFCA's activities which enhance the quality of life in our neighborhood. As of press time, 282 of the 853 households have paid. Participation rates by section are Greenbrier Section-34%, South-side-33% and Northside-31%.

Improvements at Route 50 and Park Drive

Arlington County is planning to make safety and access improvements to the intersection at Arlington Boulevard and Park Drive. The project will reduce speeding and the incidence of collisions and will create better access and crossings for pedestrians, transit users, cyclists and those travelling on the shared-use paths parallel to Arlington Boulevard. The proposed design for the intersection features new sidewalks and crosswalks, curb and gutter, upgraded signals and pedestrian call buttons, accessible ramps and new trees.

Currently, the project is in the design stage at 50% complete and was presented at the Nov 2011 AFCA meeting. County staff will meet again with residents at AFCA's Feb 15 meeting when the design will be 75% complete. Once the community has reviewed the project, the engineer will develop construction documents. The project is expected to begin construction in summer 2012.

Smoke-Free Parks

R-E-S-P-E-C-T: There's a new level of respect in our neighborhood parks. And it has a sign. Arlington County has posted signs in our parks and recreation areas asking us to respect our community values related to a healthy and safe environment by reducing second-hand smoke exposure in parks. Smoke-Free Parks makes sense:

- -- According to the U.S. Surgeon General, there is no safe threshold of exposure to second-hand smoke. It has over 4,000 chemicals in it, and most of these chemicals are toxic and cause cancer.
- -- Parks are healthy places for youth, families and community. The more tobacco-free places we have the fewer opportunities youth have to start using.
- -- The Smoke-Free Parks Initiative promotes positive role modeling. Adults are role models and the more youth see tobacco use, the more it becomes an accepted norm and the more likely they are to use tobacco products.
- -- The Smoke-Free Parks Initiative reduces litter. In smoke-free parks you won't see discarded cigarettes that pollute land and water. Further, discarded cigarettes are often ingested by toddlers and pets and they diminish aesthetics of parks and nature and cost the County in additional maintenance expenses.

Trailhead Project Moves Forward

Arlington County's Park and Recreation Commission last month approved a \$15,000 Park Enhancement Grant to beautify the trailhead located at the foot of N. Greenbrier (pictured at right). The project was proposed by an ad-hoc group of neighbors from the 100 block of N. Granada to better and more safely connect our community to Four Mile Run and the WO&D bike/hike/jog trail network. The County Board is expected to give final approval at its January 21 meeting.

The project is the outgrowth of efforts by neighbors who, since April 2008, have conducted semi-annual cleanups of the trailhead and the banks of Four Mile Run below it. The neighbors will be out again this coming Saturday, April 21 (Earth Day weekend). Anyone who uses that trail is welcome to join in the clean-up effort.

Four years of 30-person volunteer cleanups have removed tons of trash and invasive plants. However, the neighbors decided to apply for the grant after concluding that outside assistance was needed to reduce the invasive plant threat to a point where it can be kept in check and that the addition of a few pieces of park equipment would improve the community's connection to the parkland.

The project will fund a contractor to remove invasive plants from two acres on either side of the trail leading down into the Four Mile Run watershed. The contractor will make a first sweep in the coming months and will return in a year to remove surviving invasives that sprout again. This will remove the thicket of invasive plants that now chokes the area during the growing season and will thereby improve trail visibility to walkers and cyclists going up and down the winding path.

Other project elements focus on the trailhead itself. Two non-native evergreen trees at the trail entrance will be relocated (they were apparently planted years ago by a former resident without County approval) thereby revealing the native forest beyond. In their place, several new features will convert the site to an attractive focal point overlooking the parkland. A large flat bolder that is suitable for seating will be installed to provide a spot for trail users to pause to rest. An information kiosk will be installed to provide info on community events and the natural environment.

A new, specially-commissioned map of Arlington Forest will be created for display in the info kiosk that will depict details of nearby walking trails. That map will be reprinted in this newsletter so all residents can have a copy.

The County will likely also consolidate the plethora of signage near the trailhead and relocate the trash can from around the corner to the trailhead area. All the project elements should be accomplished by this summer.

Due to limited funding, money was not approved to

paint the rusty street barricade located at that spot. However, the Department of Environmental Services is currently studying whether or not to simply remove the old, unsightly barricade.

This is apparently the first project in Arlington Forest that has won funding under the annual Park Enhancement Grant program. The process was competitive, with over a dozen neighborhoods around the County applying for the program's limited funding.



Crime Watch

For the second year in a row, a rash of holiday season car break-ins hit Arlington Forest. This time, GPS devices and other valuables were stolen from a dozen unlocked cars in Northside (100 block of N. Columbus) and nearby Bluemont the night of Dec 19. That same night, a Honda Odyssey loaded with gifts was stolen from Bluemont (it was recovered a week later after it crashed in the District with four youths seen fleeing the scene).

The robberies confirmed the advice that Corporal Beth Lennon of the Arlington County Police Department gave at the AFCA meeting on Nov 16: do not leave valuables visible inside cars. Corporal Lennon reported that serious incidents such as house burglaries are rare in our neighborhood, but that car break-ins and other petty thefts (such as of unsecured bikes) are more common.

She urged residents to report all incidents to the police, even if the losses were minor and the criminals long gone. Reporting incidents allows the police to look for trends that might prompt them to increase police cruiser patrols in the neighborhood. Also, the police often fingerprint cars that have suffered break-ins and such evidence could help to identify and convict crooks responsible for dozens of crimes.



Neighborhood Notes

Our family moved to Arlington Forest in 1999. Since then, we have noticed slow but steady changes in our neighborhood. For example, at first our two preschool daughters were almost the only kids on the block. I am not sure if a Barrett School bus even stopped near us back then. Over the last decade, more and more young families have moved in. Today, kids swarm the corner school bus stop.

Just as kids have grown, so too have many of our neighborhood's trees. For example, the evergreen tree in our front yard is noticeably taller than when we moved in. Conversely, two enormous Dutch elm trees in our back yard succumbed to disease and had to be removed.

Of course, there also have been architectural changes throughout Arlington Forest. Several years ago when we decided that our original front door was too cracked and weathered to last much longer, I used daily walks with my dog as a cover for checking out replacement doors throughout the neighborhood. Studying those houses highlighted to me just how individualized many have become over the decades.

Constructed primarily between 1939 and 1948 from ten base designs (varying by front entrance location, roof

design, construction materials and other factors) and initially sold for a grand total of \$5,990, most Arlington Forest houses have been modified over the years by the addition of side or rear expansions, a front porch or other renovations. But almost all retain the iconic Colonial Revival Style which helped to qualify Arlington Forest for being added to the National Register of Historic Places in 2005.

Neighbors with whom I have spoken agree that it would be a shame if we ever started seeing teardowns that replaced our neighborhood's charming Colonials with generic McMansions. The most likely perpetrator would be a developer buying an original house that had few or no modifications. But any competent builder would hopefully note the solid construction of our houses and thus undertake renovation instead of replacement.

Passing of Pauline Cohen

Pioneer Arlington Forest merchant and resident Pauline Cohen died Nov 4 at age 95 in Culpeper. She and husband Isadore "Jack" Cohen (who died in 1998) were the first Arlington Forest Shopping Center merchants. They opened a grocery store in 1940 and converted it to Arlington Forest Delicatessen and Carry Out Shop in 1942 after the A&P Supermarket opened nearby (the location of their shop can be seen in the center of this newsletter's page 1 masthead which was drawn in 1948). Two generations of Foresters were satisfied customers for the next 42 years.

Initially prohibited from living in Arlington Forest due to the neighborhood's then-restrictive covenant prohibiting non-Christians, the Cohens eventually bought a house near the shopping center in which they lived until they closed the delicatessen and retired in 1984 after new shopping center owners tripled rents for all merchants.

Original Arlington Forest resident Ellie Eshelman (who lived here from 1941 to 1958 and now resides in Virginia Beach) recently provided this remembrance:

"I was almost four years old when my sister and I went to Jack's Deli for the first time. Mom gave each of us a penny. When I returned home and showed mom my little package of candy corn, she opened my other hand and saw that I still had the penny. (It never crossed my mind to give Jack the penny.) She told me the penny was for Jack, and sent us back to the deli. I handed Jack the penny and he received it with an easy smile. Jack's was a good place for me to return my soda bottles for a few pennies, and he never seemed to mind if I took a free look at the comic books because I usually bought a package of cupcakes before I left."

"Jack was a tall, nicely built man. He had a receding hairline and dark, wavy hair. Jack usually sat on a stool behind the register between the giant dill pickle jar and the meat case. He wore a white bib apron and always had a pencil tucked behind his ear. Sometimes his wife Pauline was there and sat on a stool beside him. Pauline was petite. She wore her long, dark hair in a hairnet and sometimes put a flower in it. She had beautiful hands and I noticed her nails were always polished."

"All sorts of exciting things were going on at the shopping center. Kids on bikes. A bus driver going for coffee at Mrs. Beasley's counter. The park workers going for lunch. Jack's screen door at the Deli opening and closing with kids buying candy and putting their roller skates back on. Jack and Pauline were always there; the shopping center's mainstay. They were an extremely kind and gentle couple."

Around the Forest

Columbus St. Safety Project: The County has started on the Columbus Street/Arlington Blvd. traffic safety project. They laid down the new median and will soon add additional signage among other safety-related upgrades.

Carlin Springs Bridge Project: The County has selected the configuration to be used in reconstructing the Carlin Springs Bridge over N. George Mason. Rejecting an option that would have removed one vehicle lane, the new design will keep the four current vehicle lanes while adding bike lanes and widening the sidewalks. To fit all that in, the bridge will be widened by four feet, the vehicle lanes will be narrowed, and the central median will be removed. The project will also add upgraded safety features including pedestrian safety lighting under and above the bridge, new approach guardrails, and improved signage. Structural upgrades will include concrete support structures repair and replacement, high-performance concrete bridge decking and new bridge railings. Work will likely begin late this year or in early 2013.

Arlington Forest Shopping Center: The Davita Medical dialysis center opened last September on a 20-year lease in the large space formerly occupied by Country Curtains (and before that by A&P Supermarket, 7-11, and then Duron Paints). Next door, Little Quiapo Restaurant closed late last year (opened 1986). It remains for lease, as does the space vacated in 2007 by Mrs. McGregor's Garden Shop (opened 1985).

Snow Watch: We have gotten off easy so far this winter, but if more than a dusting of snow eventually falls, please keep in mind the County ordinance requiring residents, businesses and churches to remove snow and ice within 24 hours after snowfall ceases (within 36 hours if snowfall exceeds 36 inches). Despite the 24-hour rule, the County urges shoveling "as soon as possible" since snow and ice left for any length of time could cause a pedestrian to fall and be injured. If you see a hazardous sidewalk that has not been cleared, you can report it via an online form so the County can investigate. You can also report streets that have not been plowed in a timely manner. Search "snow" on the County website for details. If you need help shoveling, check out Kids for Hire on page 14 for a list of energetic neighborhood students who are ready to assist.

Amphitheater: Both the County's quarterly newsletter and the end-of-year Arlington Sun Gazette listed the renovation and reopening of the Lubber Run Amphitheater as one of the top events of 2012 in Arlington County. The save the amphitheater effort was spearheaded by Arlington Forest residents and strongly supported by AFCA.

Tree Steward Program: TreeStewards of Arlington and Alexandria are volunteers dedicated to improving the health of our urban trees through educational programs, tree planting and care, demonstrations and tree maintenance throughout the community. New volunteer training will be held on Wednesday evenings, starting Feb. 8 through April 2012, with some Saturday mornings. Fun and interactive training is provided by recognized experts in tree care and citizen advocates. Learn how to care for trees on the streets, in parks, at schools, churches, temples, and your neighborhood. Please Drive Nice: With pedestrians, kids, pets, cyclists, and forest animals crossing our neighborhood streets, it is vital for drivers to adhere to traffic regulations by signaling turns, coming to a halt at stop signs and not speeding. Especially on hilly or curvy streets which offer a limited sight distance, keeping the speed down can mean the difference between stopping or not stopping in time when something unexpected happens.

Time to Build and Play

In recent years the term "nature-deficit disorder" (coined by Richard Louv in his book Last Child in the Woods) has become common in today's youth. A recent study by the Kaiser

Family Foundation found that kids over 8 spend over 7 hours a day in front of a screen (computer, TV, smartphone, etc)! To counter this, movements like No Child Left Inside and Children and Nature Networks have been started.

Here at the nature centers we have always loved being outside and taking you with us; fishing, birding, hiking, camping, and more. We now are taking steps to offer you more chances to be outside. Recently Long Branch Nature Center and Friends of Arlington Parks have received a Park Enhancement Grant from Arlington County for a total of \$11,539 to put in a Nature Discovery Area!

Right now there are no natural play-discovery areas in Arlington County Parks, so this will be the first. Our area will have no "play equipment" - the only furnishings will be natural materials, rocks, wood, water, and a child's imagination. The space is there for kids to explore, create, climb, and play in natural setting without worry about harmful plants or animals or getting lost.

We are very excited about this project and look forward to your support and the projects' inception. The site is located below the nature center, steps from the stream crossing, with access from the paved trail and hiking trails. Some work has already begun in space, with old trees being cut and cleared from the site, making way for further clean-up and new features being added.

We still need some helping hands to make this a successful project. We'll need volunteers to remove unwanted plants, put play features in place, come up with a great name, spread the word, maybe start a blog, and maintain the Nature Discovery Area once completed. As you can see, there is much yet to be done. If you'd like to help in any way or be updated on our progress, please let us know. We'd love for you to be a part in creating Arlington's first natural play area!

Market Update

Happy New Year! 2011 was another good year for real estate in the Metro DC area and Arlington was one of the better markets. In Arlington Forest there were 22 homes that sold and settled (per MRIS) with an average list price of \$594,520 and an average sold price of \$585,136 averaging 50 days on the market. Seller subsidies averaged \$4,750, with a high of \$15,000.

Mortgage interest rates have remained low. As of 1/6/12 the fixed rate for conventional loans is at 3.875% for Conforming loans up to \$417,000, 4% for Conforming Plus loans up to \$625,500 and 4.75% for Jumbo loans. FHA fixed rate loans are at 3.75%, loan limit of \$729,750. VA loans with 100% financing up to \$625,500 are at 3.875%.

As part of the temporary resolution over the Tax Cut Extension congress decided that mortgage borrowers should foot part of the bill, and increased the "Guaranty Fees" that Fannie Mae and Freddie Mac charge to lenders that securitize Mortgage Backed Securities with the Agencies. On 1/4/12 BB&T announced a change before their competitors do the same, and estimated the increase to roughly 0.125% in the rate. The real kicker on this is that the payroll tax extension only for 2 months and the G Fee increase is for 10 years.

A new sales contract for the Metro DC area is in effect as of 1/1/12. The new contract eliminates boilerplate mandates for property condition and walk through items. In practice this means that the seller has no obligation to repair mechanical, electrical, plumbing and appliance defects. The purchaser must request every item that is required to be repaired.
